SUBJECT: Urgent Action on Corruption and Irregular Issuance of Citizenship to Illegal Foreigners

1. Introduction

This memorandum serves as a formal complaint and demand for immediate action regarding the continued corruption and irregular issuance of South African citizenship and documentation to illegal foreigners, particularly in the security and trucking sectors. Despite previous engagements with the Department of Home Affairs and assurances of investigations, there has been no tangible progress, and the problem persists, worsening the country's security and economic situation.

2. Background and Previous Complaints

Numerous reports and complaints have been submitted regarding:

Fraudulent acquisition of South African identity documents and citizenship by illegal foreigners.

Corruption within Home Affairs offices, where officials facilitate illegal documentation in exchange for bribes.

The influx of undocumented foreigners in the security and trucking sectors, displacing South African workers and increasing crime risks.

A lack of proper vetting processes for foreign nationals working in key sectors affecting national security and economic stability.

Despite multiple engagements, investigations have either not been concluded or their outcomes remain unknown to the public. This raises concerns about institutionalized corruption and negligence within the department.

3. Key Concerns

Compromised National Security: The illegal issuance of citizenship enables criminals and undocumented individuals to operate freely, contributing to human trafficking, drug syndicates, and other organized crimes.

Displacement of South African Workers: South Africans continue to struggle with high unemployment while illegal foreigners dominate security companies and trucking jobs, often under exploitative conditions.

Lack of Accountability: There is a persistent failure to prosecute officials involved in corruption, creating a culture of impunity.

Undermining South African Sovereignty: Granting citizenship and work permits to illegal foreigners undermines the integrity of our immigration system and national laws

4. Demands for Immediate Action

1. **Release of Investigation Reports** – We demand full transparency on the progress and findings of previous investigations regarding fraudulent citizenship and corruption in Home Affairs.

2. **Arrests and Prosecutions** – Officials involved in corruption must face criminal charges, and illegally obtained documents must be revoked.

3. Audit of Citizenship and Permanent Residency Applications – A full-scale audit must be conducted, focusing on individuals who acquired South African documentation in the past decade.

4. Tightened Immigration Enforcement – Implement stricter vetting processes, deport illegal foreigners, and crack down on corrupt Home Affairs officials.

5. Industry-Specific Reforms – Conduct urgent inspections in the security and trucking industries, ensuring compliance with labor and immigration laws.

6. Conclusion

Failure to act on these demands will confirm suspicions that Home Affairs is complicit in the destruction of South Africa's sovereignty and the rights of its citizens. As concerned citizens, we will escalate this matter through legal, political, and public avenues if the department continues to neglect its duties.

We expect a formal response within 14 days of receiving this memorandum.
