We note with interest what you stand for and advocate for, however we gather here today 17 JULY 2025, discontent and in disagreement on what you stand for NOTING THAT:

R W Johnson was born in England, he was a British and Zimbabwean journalist who migrated to South Africa. He became the first director of Helen Suzman in 1993. Their agenda was to protect minority (white) foreigners in South Africa.

Raenette Taljaard who was an Democratic Party (DP) member of Parliament in the apartheid regime. He also served in the new dispensation when DP was converted to DA. They have been serving the interest of minority the same minority which hired illegal immigrants in their big companies to maximise profit and create xenophobic elements. Cause they have deliberately sidelined Black South Africans in their companies. Majority of them owns farms, security companies, hospitality industry to name the few!

OUR DEMANDS

1. Transparency Issues: Critics call for SERI to publicly reveal its funding sources to ensure accountability.
2. Transparency Issues: Critics call for SERI to publicly reveal its funding sources to ensure accountability.
3. Illegal Street Trading: SERI has contested the eviction of undocumented immigrants reportedly engaged in illicit trading in Johannesburg's central business district (CBD), including initiating legal actions against the City of Johannesburg and supporting opposition to Operation Dudula.
4. Public Safety Risks: Informal traders obstruct sidewalks and contribute to criminal activities, such as robbery and drug trafficking, particularly in areas like De Villiers Street.
5. Foreign National Representation: Many of SERI's personnel are foreign nationals functioning as lawyers or legal advisors, raising questions about their influence.
6. Criticism of Operation Dudula: SERI has accused Operation Dudula with wrongly attributing the death of David Nyathi, a Zimbabwean national, was murdered in Diepsloot in April 2022, without substantiating evidence and attempting to undermine the movement's credibility.
7. Crime and Squatting Allegations: Foreign nationals, whom SERI defends, are engaging in criminal activities and illegal squatting in the county.
8. These points of contention suggest a complex interplay between advocacy for human rights and concerns about public safety and order.
