Memorandum

Operation Dudula is an organization dedicated to ensuring that the laws of our country are upheld. As a country, we have a constitution that guides us, supported by various policies, including immigration laws, which require careful consideration and adherence. We stand united with the citizens of South Africa.

While we respect the constitutional mandate of the SAHRC to protect and promote human rights, we believe that the Commission has become biased and complicit in shielding certain groups—particularly illegal immigrants and foreign nationals operating unlawfully in our communities—while vilifying law-abiding and patriotic South African citizens who demand accountability and justice.

Preamble:

The national institution was established to support constitutional democracy, it must be committed to promote respect...

However we note with serious concern, the following:

1. One-sided Accusations of Xenophobia:

The SAHRC has repeatedly labeled Operation Dudula and similar community-driven initiatives as "xenophobic" and "vigilante." This misrepresents our core mission: to advocate for the prioritization of South Africans in jobs, housing, health services, and business opportunities, especially in impoverished areas.

2. Silencing of Legitimate Community Voices:

Your Commission has taken an active legal role in court cases opposing Operation Dudula, such as Kopanang Africa Against Xenophobia & Others v Operation Dudula, without engaging with us meaningfully to understand our grievances. This constitutes persecution of those exercising their right to free speech and protest.

3. Protection of Illegal Activity Under Human Rights Pretense:

By defending foreign nationals who are in South Africa illegally or engaging in unlawful business operations, the SAHRC appears to be undermining the rule of law, border integrity, and national sovereignty.

4. Lack of Action Against Corruption in Immigration and Policing:

We note the Commission's silence on the bribery, corruption, and misconduct within Home Affairs and SAPS, which facilitates illegal immigration. Communities feel abandoned.

5. Endangering Public Peace:

The Commission's rhetoric and legal actions often escalate tensions by failing to acknowledge the frustration and suffering of unemployed, under-resourced, and marginalized South Africans.

1. A National Inquiry into the Impact of Illegal Immigration:
SAHRC must initiate or recommend a national human rights inquiry into how illegal immigration impacts South Africans' access to jobs, services, and safety—especially in informal settlements and townships.

2. Accountability from Chapter 9 Institutions:
We demand transparency on how the SAHRC selects which cases to take on, and whether it is truly representing the majority of South Africans or foreign-funded interests. Please see some of many cases.....

3. Many South Africans are still experiencing deep- inequalities and lack of access to basic services/ not enough access to healthcare, education, housing as well as sanitation, all this points to the failures of SAHRC/ furthermore their failures in handling cases of racial discrimination complaints.

4. Engagement with Community Leaders:
SAHRC must hold a public town hall in Soweto or another township before August 31, 2025, to hear directly from ordinary citizens—without NGOs or foreign intermediaries controlling the narrative.

5. Stop the Vilification of Operation Dudula:
We call on SAHRC to immediately cease branding our movement as xenophobic or vigilante, and instead open a dialogue with community-based movements seeking lawful and peaceful solutions.
