Memorandum

Operation Dudula is an organization dedicated to ensuring that the laws of our country are upheld. As a country, we have a constitution that guides us, supported by various policies, including immigration laws, which require careful consideration and adherence. We stand united with the citizens of South Africa.

Preamble:

The institution is dedicated to advancing socio-economic rights, advocacy and support for individuals and communities, in addressing the gaps in policy formulation and implementation. To tackle inequality to promote realisation of socio-economic improvement for the marginalised and impoverish communities. However we note with serious concern, the following:

Your organisation is fostering an environment of lawlessness in South Africa by advocating for the rights of undocumented immigrants and challenging our efforts to reclaim urban spaces. Detractors highlight several key points of concern:

1. Transparency Issues: Critics call for SERI to publicly reveal its funding sources to ensure accountability.
2. Illegal Street Trading: SERI has contested the eviction of undocumented immigrants reportedly engaged in illicit trading in Johannesburg's central business district (CBD), including initiating legal actions against the City of Johannesburg and supporting opposition to Operation Dudula.
3. Public Safety Risks: Informal traders obstruct sidewalks and contribute to criminal activities, such as robbery and drug trafficking, particularly in areas like De Villiers Street.
4. Foreign National Representation: Many of SERI's personnel are foreign nationals functioning as lawyers or legal advisors, raising questions about their influence.
5. Criticism of Operation Dudula: SERI has accused Operation Dudula with wrongly attributing the death of David Nyathi, a Zimbabwean national, was murdered in Diepsloot in April 2022, without substantiating evidence and attempting to undermine the movement's credibility.
6. Crime and Squatting Allegations: Foreign nationals, whom SERI defends, are engaging in criminal activities and illegal squatting in the county.

These points of contention suggest a complex interplay between advocacy for human rights and concerns about public safety and order.
