SANCO Greater Tshwane Region Statement on outcomes of the RTT Meeting and Recent Political Developments

Treatment towards SANCO

On Saturday, 11 October 2025, SANCO Greater Tshwane Region held its RTT meeting. Today, we are conducting a press briefing after that meeting, addressing recent developments in the region. SANCO would like to express its deep concern and disappointment over undermined efforts. Insufficient deployments and lack of recognition are unacceptable and a total embarrassment to our organization.

SANCO, reached out to the ANC, on 13 October 2025, through a letter. The letter emphasized an important principle that will ensure that its leaders receive the same respect shown to their leagues and their coalition partners. Respect among Alliance partners is fundamental to the strength of the Alliance. The recent developments showing preference for their leagues at the expense of the entire alliance is humiliating.

SANCO will not allow its leaders to be disrespected or taken lightly to satisfy the political interests of ANC leaders. The ANC has chosen to value narrow political interests and its relationships with other political parties more than its alliance partners. Those opposition parties won't be present on the ground with the ANC during elections in the contested political terrain.

The Unity of the Alliance

It's all hands-on deck as we observe that opponents of the NDR have gained confidence due to the tactical defeat experienced during the strategic setback that occurred at the National General Elections. That is why we cannot allow "big brother" tendencies in the Alliance because it will derail us from building a prosperous democratic society.
